#### 5. 2013 BFTA Competition Rules and New Open Class

Roger briefly provided background for all those present of the issues regarding the legal discussions of the 2013 Rules, approved at the November 2012 AGM subject to review, which have removed the adapted positions from the Main Shoot rules but introduced a new Class named Open Class where there is no restriction on any shooting position that a participant chooses to use (other than the position conforms to the Main Shoot Rules). It was confirmed that the Insurers are content to continue to provide both Liability and Legal Fees cover.
